In an audit released on the morning of Wednesday, April 24, 2024, the State Auditor's Office reviewed the education agencys work and found it failed to clearly follow all the required steps before offering a no bid \$4.4 million contract to SPEDx, which was hired to analyze how schools serve students with disabilities and help create a long-term Special Education plan for the State.

"The Texas Education Agency first initiated a top-to-bottom review of contract processes in Nov. of last year. It has resulted in a massive set of process changes, personnel actions, and steps to address proper documentation," Texas Education Commissioner Mike Morath, a former member of the Dallas Independent School District's board of trustees, in a statement this week said. "The changes we are making are designed to insure an agency culture of efficent compliance".

State auditors also said that the Texas Education Agency failed to "identify and address a preexisting professional relationship" between a SPEDx subcontractor and the agency's "primary decision maker" for the contract. Peggy Castle — that decision maker and the agency's Deputy Commissioner of Academics — did not disclose that she had received professional development training from the person who ultimately became a subcontractor on the project.

No. 4 - "Premier" is spelled wrong. It should be "premiere." Students should at least fix that. They can also change it to a less wordy and more straightforward phrase as indicated here.

There are four errors per item.

If fixing one error creates another, it counts as one.

Notes for judges

¶2 – State Auditor's Office is the proper name of the office.

¶3 — There are several ways to fix the problem, but the verb of attribution, "said," is too far away from the subject.

¶5 — The opinion in this paragraph, while loosely attributed to the auditors, goes overboard.

Three paragraphs begin with "State auditors...." It would be ideal to break that up somehow. The final paragraph is also unrelated to the other paragraphs and could probably use a better transition to make that clear.

Tips for judges

Part 3

This section is ranked to break a tie in the combined scores of parts 1 and 2. Assign no points.

Judges should compare the papers of students who tied, ranking them accordingly.

When judging Part 3, holistically read the changes the student indicated starting with the highest level of editing.

- Highest level: Are there any legal or ethical issues with the story?
- Middle level: Does the story use the right sources? Does it flow?
- Lowest level: Grammar, spelling, punctuation, style
