### **Frequently Asked Questions**

The information hub for the meet is the CX Debate State Tournament webpage on the UIL website. Consult it frequently for updates.

There are no entry forms or fees for the CX State Meet. Online results from your district meet serve as your official entry unless your district is required to also submit certification forms. See contest rules for details. All schools must submit judging forms. Certification forms (to be completed online) are required in the League office no later than **Feb. 16**, **2023** and are required for competition at State.

#### What tournament obligation does my school have?

Each school must provide one experienced policy debate judge for each team qualified for the CX Debate State Meet as long as that team remains in competition. Failure to do so constitutes grounds for forfeiture of the round. The coach should serve as this judge if possible or another person experienced in judging debate may be provided by your school to fulfill this obligation. Your professional contribution to the quality of the competition is greatly appreciated. All schools must submit required judging forms to the League no later than **Feb. 16** in order for your school to compete. Paradigm information of State Meet judges will be provided in advance of the meet on the State Tournament webpage on the UIL website.

#### Where do I register?

Registration of qualifiers and judges is required in the tournament managment system at Tabroom.com. Coaches will be notified when it is open for registration.

There will be no in-person check-in at tournament headquarters the day before the tournament. Check-in for State CX Debate for all conferences will be held **online** on the State Tournament webpage on the UIL website (not Tabroom).

#### What if I cannot come to State Meet?

Notify your principal immediately if you are unable to attend State Meet. Your principal should then notify the Spring Meet District Director and Jana Riggins, State Director at the League office. Alternates will need sufficient time to make arrangements for competing, so do this in a timely manner

#### • How can I be at the right place at the right time?

Download the Official CX Debate State Meet Program and a campus map before you arrive or download the UIL State Mobile App, the Official App of the State Championships available from the App Store or Google Play. It is imperative that you be on time to rounds.
