Carrie Klypchak- Acting

Dr. Carrie Klypchak currently serves as a Professor of Theatre, specializing in acting and directing, at Texas A&M University-Commerce. Dr. Klypchak is a New York, conservatory-trained professional actor, a professional and collegiate director, an active teaching artist, and a published performance scholar. In 2012, 2013, 2016, 2018, 2019, and 2023, she was honored to serve as an OAP State Meet judge; in 2013, she was also named the University Educator of the Year by TxETA. Dr. Klypchak has participated in the UIL OAP system as an actor, director, clinician, and judge and considers it a privilege to be a part of this important educational experience.

Ray Newburg

Ray's UIL One-Act Play experience started as a student at Amarillo High School where, in 1988, he performed with the company of PEER GYNT that advanced to the state contest. Since then, UIL OAP has been in his blood. When he first started teaching college in DFW, he served as a contest manager at Tarrant County College from 1996-2000. After moving home to Amarillo in 2000, he finally decided to take the plunge and certify as an adjudicator. Ever since, he has been consistently contest managing and judging all over the state. To date, he has contest managed over 40 and judged over 100 OAP contests ranging from Zone to Region levels. He has previously served as the Region 6 Texas Chair for the Kennedy Center American College Theatre Festival and as the University/College Vice President and Scholarship Coordinator for Texas Educational Theatre Association. In 2004, Ray received the Teacher of the Year Award for Community Colleges from the TxETA. Ray believes in UIL OAP as a guiding force in this state, and he is proud to be a part of so many students' theatre education.

Ezekiel Morgan

Mr. Morgan has worked with UIL for more than 27 years,hosting, contest managing,adjudicating and directing. Ezekiel graduated from the High School for Performing and Visual Arts in Houston and received his BA from Prairie View A&M University with an emphasis in acting and directing and a MA in Counseling and Education Leadership and a Master in Theatre from Texas A&M University- Commerce . He studied abroad at Williams University with The Williamstown Theatre Festival, (ACTF) Irene Ryan National Winner in 1997 performing and serving as assistant director at the Kennedy Center, worked as an apprentice in Acting and Directing. Understanding the importance of Educational Theatre, Ezekiel has position himself through education and experience to manifest his knowledge to all levels of the UIL contest. Ezekiel served as a Committee member on the Standards of Adjudication and Judging Practice Committee and currently a Board of Director for TTAO. Events will run as scheduled. PLEASE DO NOT BE LATE!

Rehearsal Documentation

Please be at least 30 minutes early for your rehearsal. *Arrive in the Loading Dock with all students and staff.* This will ensure that we stay on schedule! When you arrive, please contact either the CM or host and someone will greet you at the back doors. Directors, please bring all necessary documentation with you to rehearsal:

- Publisher permission (not required if play is in public domain)
- Proof of Royalties (not required if play is in public domain)
- Integrity script w/ cuts
- Community Standards Form w/ signature)
- Region Fee (check or copy of purchase order)

And if necessary:

- Substitution Forms
- Set Additions
- Permission to perform a play not on the approved list

There will be full disclosure at the rehearsal. Plan to rehearse with all the set pieces, fabrics, and items that you will use in performance (prop firearms, etc. must be cleared in rehearsal).

NEW IN 2023 All weapons must be approved by the Contest Manager at the time of your rehearsal and must be stored/ locked up with the company following your rehearsal. No entrances may be made into the house with a weapon (swords may be a different case; please communicate with the CM).

Unloading/Rehearsals

Schools will unload equipment/scenery at the loading dock at the time of your rehearsal. Our loading dock is truck height, so vehicles may need to consider this when backing in. To access the loading dock, drive to the south side of the building, turn in from Wildcat Way and drive around the parking lot to the back of the band pad. Buses/Trailers can park at the back of the parking lot outside the Auditorium entrance.



Companies may unload all scenery, etc. into the shop when given the okay by one of the site crew. Once paperwork has been completed by the director and CM, your group will have one hour to rehearse. Groups will need to remove and store scenery in the assigned space (as well as spike and strike the entire unit set) by the end of the official rehearsal time.

Storage


Each school will have a designated area to store their scenery/equipment/ etc.. Expect to store set pieces/props in this space. You may also keep items in your dressing room.

Dressing Rooms

Dressing rooms will be available for each company.

Stage/Lighting/Sound/ etc.

Walnut Grove High School has an ETC ION XE lighting board. We have a 15 Area lighting plot (see below), with Red, Green, Blue, and Amber LED Stage and Cyc washes preprogrammed and LED color changing instruments from the front, top and cyc. If pre-programming is desired, please send all lighting cues to Michael Cleveland (mwcleveland@prosper-isd.net) by April 18, 2025 to allow the host school time to program your lighting cues ahead of time. Here is a Google Sheet, or an Excel Spreadsheet to record your lighting looks. Either way, you will need to make a copy of your own for editing.



We have a white cyc or black curtain upstage for your use. There is no cross over space between the cyc and back wall. There is a crossover through a back hall adjacent to the back of the stage if needed.

Stage Dimensions:

Proscenium Length - 49'10" Proscenium Height - 21'0" Apron Depth - 5'0" Stage Depth - 34'0" (proscenium to back wall)

Other dimensions:

Apron to MS Traveler - 15'9" Apron to Back Traveler- 26'6" Apron to Cyc - 31'2" Apron to Back Wall - 39'0" Calipers - 47'8"

Leg Depths: (from the back of the proscenium)

DS legs - 7'9" Mid legs - 14'2" US legs - 22'1"

If you choose to use the house sound system, we have a Yamaha TF3 sound board and will provide an Aux cord. There is no CD player in our system. Headsets are available in FOH, SR, SL, and USC

Unit Set

Walnut Grove HS will provide the basic unit set, but no door or window units available. If you plan on using any unit set doors or windows in your show, all unit set pieces must be available prior to the first rehearsal, so please make arrangements to deliver any additional set pieces to the school before the first scheduled rehearsal.

Performance Attendance

Audiences will be permitted for all performances. Students with an ID and district staff are no charge. Adult spectators without a student/staff ID are \$10 each- cash or card. Audiences will need to come in at the south Auditorium entrance (same place buses/trailers were parked). Concessions will be available for purchase and eating will be permitted in the lobby.
