Robin Robinson currently directs at Main Street Theatre in Houston, several times a year. As a retired educator, she values her years in the classroom as well as working in regional theatre. She was the Theatre Director at Grayson College for 19 years and taught high school for 10. Professionally, Robin has directed in Houston at Main Street Theatre, Stages Repertory, and Theatre LaB Houston as well as in Austin at Capital City Playhouse and Hyde Park Theatre. Robin worked as an assistant stage manager at the Alley Theatre in Houston and Pacific Conservatory of the Performing Arts in Santa Maria, CA. Although Robin has enjoyed working in the regional world, her first love has always been education. She has served on the One Act Play UIL Advisory Committee, AO Standards and Practices Committee, and as Secretary of the Adjudicator's Organization in TETA and Director at Large on the TTAO Board of Directors. She has been a UIL adjudicator since 1989 and has judged at all levels including both State and Region. She served as the State Contest Manager for the 1A, 2A, and 3A State One Act contests from 2014-2019. She is a member of Who's Who for Outstanding Educators and was the 2014 TETA Educator of the Year for Community Colleges. He currently serves as Past-President of the Texas Educators of Theatre Association. He has adjudicated at all levels of competition including multiple state contests in 2009, 2012, 2013, 2017, 2018, 2021 and 2023. Mr. Springfield previously worked as Dean of Students and Lead Counselor for Houston's Kinder High School for the Performing and Visual Arts and served as Manager of UIL Academics for Houston ISD before moving to Fort Bend ISD to become the Assistant Director of Fine Arts for Theatre and Dance where he retired this past summer. GENERAL INFORMATION

Once district results are in speechwire Bi-District will open up for you to enter your play. You will need to do that ASAP

Plan on arriving 30 minutes prior to your rehearsal time. This will ensure that we stay on schedule!

Directors, please bring all necessary documentation with you to your rehearsal:
Permission to produce play not on approved list (from UIL)
Publisher Permission to cut a full length play
Proof of royalty payment (Approved PO, Copy of Check, Receipt from company)
UIL permission for scenic items requiring special approval
Permission to add characters or change character gender (if needed)
Official scripts (Must be an original script, not a copy, and must have cuts if you are doing scenes from - sf)
Substitution forms
Set additions approval
Community Standards Compliance Form with signature
Sound log no longer required. Live music used on stage cues recorded in the integrity script.

Please make sure to read your OAP Handbook. If you fail to bring any of the necessary paperwork you will not be able to perform. All documentation must be presented prior to the start of your scheduled rehearsal.

REHEARSAL SCHEDULE

There will be full disclosure at the rehearsal. Plan to rehearse with all the set pieces, fabrics, and items that you will use in performance (prop firearms, etc. must be cleared in rehearsal). 

ADDITIONAL REHEARSAL/PERFORMANCE INFORMATION

Unloading

Schools will unload equipment/scenery at the loading dock door.

Companies are welcome to unload all scenery and costumes 30 minutes prior to the scheduled rehearsal time (as indicated on schedule). Upon arrival you will be greeted by contest personnel. On-site personnel will be there to assist with directives.

Rehearsal

Each group will have one hour to rehearse. Groups will need to spike and to completely strike the stage by the end of the official rehearsal time.

Please be on time. Events will run as scheduled.

Strike/Loadout

Following your performance, each company will strike out to the dock and load out. If there is inclement weather, adjustments will be made.

Please use the parking lot adjacent to the fine arts center for all buses and trucks and for visitor parking during the contest.

Contest Day Arrival Time

Doors will be open at 7:00 am for schools to go to prep rooms.

Dressing Rooms

Each company will be assigned a classroom during the duration of the competition. Please remember the dressing rooms are classrooms and do not contain mirrors: therefore, you will need to provide your own. As a courtesy to the classroom teachers, please leave rooms as you find them. Please leave the space as clean as you found it.
