Visitor Parking & Admission Instructions

Campus Safety Policies

- Hondo High School is a closed perimeter campus with the exception of the front parking lot, and the main entrance of the school, which is used **ONLY** for student and visitor parking and for entering the main building of the school.
- The front parking lot, however, will **NOT** be used for OAP contestant arrival. Everyone coming to the contests should follow the parking and admission instructions below. Pictures of parking areas are attached.
- Hondo ISD also abides by a clear and bag size policy as outlined on the attached documents. Visitors will **NOT** be allowed admission to the auditorium house to watch the plays unless they are in compliance with the bag policy.
- Exceptions will be made for contest staff who need to bring in contest supplies and materials, but any patrons in violation of the bag policy will be asked to walk back to their cars and leave the bag(s) in their vehicles

Contest Staff

- Only the contest manager, technical director, and adjudicators will be allowed to enter the campus from the front on Avenue H and 27th Street (Area 1).
- Those individuals will have to park in front of the school, go to the main office to sign in and get a visitor pass and then be escorted through the campus driveway gate in order to drive down to the Fine Arts Center (FAC) and park in the west FAC parking lot next to the track (Area 2)
- There will be an HHS staff member at the front of the FAC to check bags in accordance with the district policy. Contest staff will be allowed to bring in all materials required to complete the duties of their role in the contest.

Competing Schools


- All school directors and contestants will enter from the back load-in area of the FAC, off 22nd Street between Avenue H and Avenue I (Area 3).
- After load-in, buses and/or trucks will be allowed to park in a fenced area on the west side of the track, off Avenue I between 22nd Street and 23rd Street, where a monitor will be stationed to let buses and trucks in or out as necessary (Area 4)

- If all schools intend to stay on the HHS Campus after they arrive and until the time of load-out, then the Avenue I gate will be closed and locked after everyone arrives.

Visitors & Patrons

- All patrons coming to watch the play performances will park their vehicles on 22nd Street (Area 5) or another nearby street and walk to the single fence gate on the west side of the auditorium, in the same area as the rear load-in door (Area 3).
- There will be a monitor at this gate to check bags and allow patrons to enter the campus and walk up the sidewalk to the front entrance of the FAC.
- There will also be a monitor at the auditorium lobby where patrons enter the building.
- There is no charge for admission to see the plays.

GATE 8: For buses and trucks to park after load-in. There will be a monitor here to allow trucks and buses to enter as the gate must remain closed during the school day.

GATE 11: For visitors and patrons who are coming to watch the performances. There will be a monitor here to allow guests to enter and walk up the sidewalk, around to the front of the FAC.



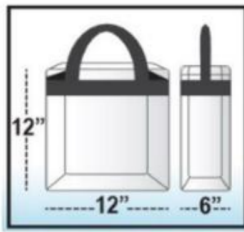

CLEAR BAG POLICY*

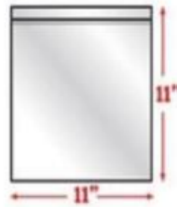
Large Bags

- Clear plastic, vinyl, or PVC
- Not to exceed 12" x 6" x 12"
- No more than one logo, not obstructing contents



Small Bags

- Small clutch bags, with or without straps
- Small bags do not have to be clear
- Not to exceed 8" x 5" x 1"



PROHIBITED BAGS

- Backpacks
- Duffle bags or large totes
- Purses larger than 5" x 8" x 1"
- Cases (camera, binocular, etc.)
- Mesh or straw bags
- Fanny packs
- Printed pattern or tinted plastic
- Bags or totes
- Folding chair bags
- Reusable grocery totes

EXCEPTIONS

- Bags for medically necessary items
- News media equipment
- Official team or other field photographers
- Booster clubs selling items with approval
- Diaper bags with a baby

*All bags are subject to inspection prior to entry, regardless of size or type.
