

## Fall 2022 Superintendent Survey

The state marching band championships are held in an alternating year format for each conference - 1A/3A/5A in odd years and 2A/4A/6A in even years. A statewide band directors survey, as well as a recommendation from the marching band rules advisory committee, indicate majority support for changing the contest to be held annually for every conference, which would make the format consistent with every other UIL championship.
